AN ORDINANCE CREATING THE POSITION OF PART-TIME COORDINATOR FOR LITTER/RECYCLING, AND PART-TIME DRIVER LITTER COLLECTORS, AUTHORIZING THE MAYOR TO HIRE SAID PERSONS AND ESTABLISHING HOURS AND WAGES, REPEALING ORDINANCE NO. 18-028 AND ANY ORDINANCE INCONSISTENT HEREWITH AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Struthers, Ohio, 3/4's of all members elected thereto concurring:

SECTION 1: That the Council of the City of Struthers, Ohio, hereby creates the position of a part-time coordinator for Litter/Recycling and part-time Driver Litter Collectors, and authorizes the Mayor to hire said persons.

SECTION 2: Said part-time coordinator for Litter/Recycling shall be paid an hourly rate of \$11.73 per hour.

SECTION 3: Said part-time Driver Litter Collectors shall be paid an hourly rate of \$11.22 per hour.

SECTION 4: Said part-time coordinator for Litter/Recycling, as well as, as parttime Drive Litter Collectors are eligible for no fringe benefits and shall work an average of twenty-eight (28) hours per week, not to exceed one thousand four hundred fifty six (1,456) hours per calendar year. It is further stated that conditions of employment shall be explained to each applicant and that he/she shall perform the duties as set out by the Mayor under the supervision of the Safety Service Director.

SECTION 5: This Ordinance is effective upon passage.

SECTION 6: That Ordinance No. 18-028 and any ordinance inconsistent herewith are hereby repealed.

SECTION 7: This ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact and part-time employees get paid, as such, this ordinance shall take effect upon its passage and approval by the Mayor.
