## CITY OF STRUTHERS Ordinance

NO. 20-023

AN ORDINANCE AMENDING ORDINANCE NO. 08-016
ENTITLED "AN ORDINANCE REGULATING THE USE OF
PUBLIC AND PRIVATE SEWERS AND DRAINS, THE
INSTALLATION AND CONNECTION OF BUILDING SEWERS,
AND THE DISCHARGE OF WATERS AND WASTES INTO THE
PUBLIC SEWER AND WASTE TREATMENT SYSTEMS,
PROVIDING PENALITY FOR VIOLATION THEREOF AND
DECLARING AN EMERGENCY" AND DECLARING AN
EMERGENCY.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Struthers, Ohio, <sup>3</sup>/<sub>4</sub>'s of all members elected thereto concurring:

**SECTION 1.** That Ordinance No. 08-016, Section 1, is hereby amended to read as follows:

Section 1: For the purposes provided in this Ordinance there is levied and charged upon each lot, parcel of land, or premises having an active connection with the sewerage system or otherwise discharging sewage, industrial wastes, water, or other liquids, either directly or indirectly, into the City's system, sewer charges, payable herein provided and in amounts to be determined as follows:

\$3.32 PER ONE HUNDRED (100) CUBIC FEET OF WATER USED PER MONTH (EFFECTIVE September 1, 2020).

Any premises located outside the City Limits, which must be served by the system shall be governed by rates established by contract and approved by the Council of the City of Struthers.

In addition, for the purposes provided in this Ordinance, there is a Debt Service Charge levied upon each lot, parcel of land, or premises having an active connection with the sewerage system or otherwise discharging sewage, industrial wastes, water, or other liquids, either directly or indirectly, into the City's system. The debt service charge is fixed herein and is as follows:

Debt Service Charge effective April 1, 2008 - \$3.00 per month.

**SECTION 2.** That Section 1 of Ordinance No. 08-016 is hereby amended deleting the previous sewage user charges and inserting an amended sewage user charge.

**SECTION 3.** That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace and the health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that amendments must be made as soon as possible, and, as such, this ordinance shall take effect immediately upon its passage and approval by the Mayor.
