***AN ORDINANCE AMENDING ORDINANCE NO. 07-050
ENTITLED "STORM WATER UTILITY ORDINANCE" AND
DECLARING AN EMERGENCY.***

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring:

SECTION 1. That Ordinance No. 07-050, Section 1.7 (b), is hereby amended to read as follows:

Single Family Residential Fee. The Council finds that the intensity of development for most parcels of real property in the City classified as single family residential is similar and that it would be excessively and unnecessarily expensive to determine precisely the square footage of the improvements (such as building, structure, and other impervious area) on each such parcel. Therefore, all single family residential properties in the City shall be charged a flat Storm Water Management Fee, equal to the base rate, regardless of the size of the parcel or the improvements. Said flat base rate shall be \$4.50 per month.

SECTION 2. That Section 1.7 (b) of Ordinance No. 07-050 is hereby amended deleting the previous flat base rate charge and inserting an amended flat base rate charge.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace and the health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that amendments must be made as soon as possible, and, as such, this ordinance shall take effect immediately upon its passage and approval by the Mayor.
