WARN ACT INFORMATION

The Worker Adjustment and Retraining Notification Act of 1988 (the "WARN Act") is a US labor law which protects employees, their families, and communities by requiring most employers with 100 or more employees to provide 60 calendar-day advance notification of plant closings and mass layoffs of employees.

For the purposes of the WARN Act a **mass layoff** is defined as a reduction in force that is (1) not the result of a plant closing, but (2) leads to an employment loss at the employment site of 500 or more employees during a 30 day period, or a loss of 50-499 employees if they make up at least 33% of the employer's active workforce.

It requires employers to **warn** employees of upcoming layoffs ahead of time. As a heads up: the **WARN** act doesn't tend to affect **small businesses**. Instead, it typically**applies** to **businesses** who need to terminate 50 or more employees at a time.
