It was another record number of calls for service for our Department. This number would have been a lot larger but due to Covid protocols we were unable to respond to some EMS calls. These were passed along to the ambulance companies when Covid symptoms were present in order to keep our members safe and virus free. These protocols were put in place so an adequate number of Firefighters are available to protect our community.

Dear Honorable Members of Council:

The following Annual Report is submitted at the first regular meeting of Struthers City Council in January 2021 pursuant to  $\S$  733.62 of the Ohio Revised Code, which states:

The city director of law shall make a report to the legislative authority of the city, at its first regular meeting in January, of the business of his office, the moneys by him collected during the year preceding, and such other matters as he deems proper to promote the good government and welfare of the city.

This report is divided into the following sections:

- A. Business of the Law Department during 2020
- B. Monies collected by the Director of Law during 2020
- C. Other matters relating to good government and welfare of the City of Struthers

I want to state at the outset that I am thankful for the ongoing, positive interaction I have experienced throughout the prior year with City Council, other elected officials, department heads and many of the top notch City of Struthers employees. This office is part of a governmental team that has the best interests of the citizens of Struthers as its primary focus. That shared, there have been challenging moments during the last twelve months, but none has derailed the process of local governance. This is reflected in the strong record of accomplishments during 2020 which include the projects and initiatives detailed below.

Prosecuting Attorney – City of Struthers, Village of Poland, Township of Poland, Village of Lowellville, Village of New Middletown, and Township of Springfield

#### A. BUSINESS OF THE LAW DEPARTMENT DURING 2020

First, some numbers that reflect some of the basic operations of the Law Department:

#### MUNICIPAL COURT

Pursuant to § 733.52 of the Ohio Revised Code, "[t]he city director of law as prosecuting attorney of the mayor's court shall prosecute all cases brought before the court, and perform the same duties, as far as they are applicable thereto, as required of the prosecuting attorney of the county." Between January 1, 2020 and December 31, 2020, my office prosecuted 492 misdemeanor criminal cases and 1,456 traffic cases that were filed in the Struthers Municipal Court from all political subdivisions within the court's territory.

#### LEGAL ADVICE AND OPINIONS

Furthermore, § 733.54 of the Ohio Revised Code provides:

When an officer of a city entertains doubts concerning the law in any matter before him in his official capacity, and desires the opinion of the city director of law, he shall clearly state to the director of law, in writing, the question upon which the opinion is desired, and thereupon the director of law shall, within a reasonable time, reply orally or in writing to such inquiry. The right conferred upon such officers by this section extends to the legislative authority of the city, and to each board provided for in Title VII [7] of the Revised Code.

Between January 1, 2020 and December 31, 2020, I frequently provided separate instances of legal advice and/or written opinions for the offices of the Mayor, Auditor, Safety Service Director, Council members, Council as a whole, and Police Chief.

#### LITIGATION

In 2020, the Law Department worked with the Tax Department to file several lawsuits to collect income taxes due and owing to the City. A summary of those cases can be found in <a href="Exhibit A">Exhibit A</a> hereto.

Second, the following are some of the accomplishments of the Law Department during 2019:

#### BUDGET

The end of any calendar year for the City of Struthers brings with it the need for the creation, submission and approval of a budget for the succeeding twelve month period. In 2020, the Law Department requested a modest budget, and the Department was able to live within those means and actually returned an amount of unspent funding at the end of the year. In the days to come, I will meet with the Mayor to discuss my Department's budget for 2021. Discretionary areas of the Law Department's budget request are not likely to see any increases for the upcoming year. My office will continue to use taxpayer money sensibly and only spend money for reasons that are absolutely essential to the operation of the Law Department.

#### OTHER BUSINESS

The Law Department also worked closely the Housing Code Director to enforce the housing code provisions found in the City's Codified Ordinances and to revise several ordinances to expand the City's ability to enforce housing code violations.

#### B. MONIES COLLECTED BY THE LAW DEPARTMENT IN 2020

The Law Department does not directly collect money in the course of its business.

#### C. OTHER MATTERS RELATING TOP GOOD GOVERNMENT AND WELFARE OF THE CITY

 $\S$  733.62 of the Ohio Revised Code does not specify what is meant by "other matters \* \* \* to promote the good government and welfare of the city." However, I will continue to monitor governmental operations to the extent that my office has a role for doing so under the Ohio Revised Code. This includes providing Council with recommendations on the legislative process and answering specific procedural and legal questions.

#### City of Struthers, Ohio vs. Ronald S. Ciccolelli Case No. CVF20000324

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$1,334.94, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.

#### City of Struthers, Ohio vs. Thomas A. Cutlip Case No. CVF20000325

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$1,504.98, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.

#### City of Struthers, Ohio vs. Joseph Czap Case No. CVF20000326

This lawsuit was filed on July 28, 2020 seeking to recover \$93.11. After the lawsuit was filed, the taxpayer paid the amount owed and the case was dismissed.

## City of Struthers, Ohio vs. Arthur M. Cramer Case No. CVF20000327

This lawsuit was filed on July 28, 2020 seeking to recover \$1,891.20. After the lawsuit was filed, the taxpayer agreed to make an initial payment of \$500.00 and then monthly payments of \$100.00 until the balance is paid.

## City of Struthers, Ohio vs. Tracie Brown Case No. CVF20000328

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of 1,077.70, plus interest at the rate of 5% per annum from the date of judge. Subsequently, the taxpayer entered into a payment agreement directly with the Tax Department.

## City of Struthers, Ohio vs. James E. Hivner Case No. CVF20000329

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$332.25, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.

#### City of Struthers, Ohio vs. Ashly L. Kephart Case No. CVF20000330

This lawsuit was filed on July 28, 2020 seeking to recover \$209.39. After the lawsuit was filed, the taxpayer agreed to make monthly payments of \$25.00 until the balance is paid.

#### City of Struthers, Ohio vs. Johnathan A. Davis Case No. CVF20000331

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$320.56, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.

#### City of Struthers, Ohio vs. Benjamin D. Burkey Case No. CVF20000332

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$1,100.19, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.

## City of Struthers, Ohio vs. Brian Buttermore Case No. CVF20000333

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$199.58, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.

## City of Struthers, Ohio vs. Robert Fullerton Case No. CVF20000334

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$1,746.06, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.

### City of Struthers, Ohio vs. Angela Greenwalt Case No. CVF20000335

This lawsuit was filed on July 28, 2020 seeking to recover \$1,634.84. After the lawsuit was filed, the taxpayer paid the amount owed but still owes the court costs.

#### City of Struthers, Ohio vs. Fidel Gutierrez Case No. CVF20000336

This lawsuit was filed on July 28, 2020 seeking to recover \$453.93. After the lawsuit was filed, the taxpayer paid the amount owed but still owes the court costs.

#### City of Struthers, Ohio vs. Cynthia J. Green Case No. CVF20000337

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$565.61, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.

#### City of Struthers, Ohio vs. Jessica M. Hetrick Case No. CVF20000338

This lawsuit was filed on July 28, 2020. A default judgment was issued in favor of the City in the amount of \$1,125.67, plus interest at the rate of 5% per annum from the date of judge. Collections efforts are ongoing.
