**DOWNTOWN FAÇADE**

The City of Struthers is once again going to offer opportunities to enhance local business store fronts in the downtown Struthers area through a FY 2009 Community Development Block Grant.

We are currently asking for interested businesses owners to provide the information asked in an application that was sent to local downtown businesses January 13<sup>th</sup>; these applications are due back by February 1, 2010. I encourage downtown business owners to take advantage of this opportunity to enhance the appearance of their business through this block grant and its stipulations. Last year Donavito's Italian Grille, Dr. Peter Andrews and Paul's Upholstery took advantage of this opportunity.

**MAHONING RIVER CORRIDOR INITIATIVE (MRCI)**

My office sent out property profiles for an Economic Development Site Profile for MRCI partners to be used to identify property and/or buildings in the river corridor communities. The MRCI would like to market these properties on a website that was obtained through a grant. I have asked that these profiles be sent directly to my office so that I can present them to the MRCI at the end of the week.

**RECYCLING CURBSIDE MADNESS**

Since the announcement by the Mahoning County Green Team of the Curbside Madness campaign the demand for recycling bins has risen. As originally announced; the communities that register the highest per capita curbside recycling rate between November 15<sup>th</sup> and February 15<sup>th</sup> will win cash awards. Right now the City of Struthers is in 3<sup>rd</sup> place and we are encouraging residents to recycle curbside to increase awareness and more importantly to reduce the amount of trash that goes to the landfill.
