***A RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE
TO ADVERTISE FOR BIDS THE PAVING OF CERTAIN STREETS WITHIN
THE CITY OF STRUTHERS AND DECLARING AN EMERGENCY.***

WHEREAS, the City Council of the City of Struthers, Ohio, has determined to proceed with the 2026 resurfacing program; and

WHEREAS, the amount to resurface streets will exceed an amount whereby the City of Struthers, Ohio, would be required to advertise for bids for the project; and

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Struthers, Ohio:

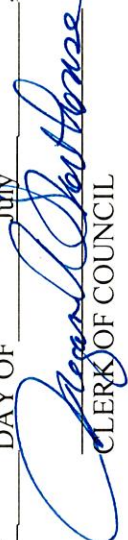
SECTION 1: The Director of Public Service is hereby authorized and directed to advertise for bids for the paving of the following certain streets within the City of Struthers:

- Creed Street (Argonne Street to Poland Avenue);
- Lincoln Street (Youngstown-Poland Road to 9th Street);
- Grimm Heights Avenue (Entire Street); and
- Eve Drive (Entire Street).

SECTION 2: Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this Council, that all deliberations of this Council and of its committees, if any, which resulted in formal action were taken in meetings open to the public, in full compliance with the applicable legal requirements, including § 121.22 of the Ohio Revised Code.

SECTION 3: This Resolution is hereby declared to be an emergency necessary for the health, safety, and welfare of the City of Struthers, Ohio, by virtue of the fact that the City of Struthers, Ohio wishes to resurface various streets in order to maintain their useful life, and as such this Resolution shall take effect immediately upon its passage and approval by the Mayor, or, in the alternative from and after the earliest time permitted by law.
