AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING TO AMEND THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY AND THE INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL 1910 TO ADDRESS WAGE REOPNENER NEGOTIATIONS CONTAINED IN ARTICLE 17, SECTION 3, OF THE COLLECTIVE BARGAINING AGREEMENT FOR YEARS 2021 AND 2022, AND DECLARING AN EMERGENCY.

WHEREAS, on December 9, 2020, Council passed Ordinances No. 20-042 adopting the collective bargaining agreement between the City and the International Association of Firefighters, Local 1910 (the "<u>Union</u>");

WHEREAS, the collective bargaining agreement is effective from November 1, 2020 through October 31, 2022;

WHEREAS, the collective bargaining agreement governs all wages, hours, and other terms and conditions of employment for full-time sworn personnel covered thereby;

WHEREAS, the City and the Union desire to enter into the Memorandum of Understanding attached hereto as <u>Exhibit A</u> (the "<u>MOU</u>") to amend the collective bargaining agreement to address wage reopener negotiations contained in Article 17, Section 3, of the collective bargaining agreement for the years 2021 and 2022; and

WHEREAS, Council finds the MOU is fair and reasonable and in the best interests of the health, safety and welfare of the City.

NOW, THEREFORE, BE IT ORDAINED by Council for the City of the Struthers, Ohio, ³/₄'s of all members elected thereto concurring, that:

SECTION 1: The Mayor is hereby authorized to enter into the MOU on behalf of the City.

SECTION 2: It is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in those formal actions, were in meetings open in the public in compliance with law.

SECTION 3: This ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health and safety and, thus, shall take full force and effect immediately upon its passage and approval by the Mayor.
