A RESOLUTION AUTHORIZING THE MAYOR TO APPLY FOR, ACCEPT, AND ENTER INTO A GRANT AGREEMENT WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES, DIVISION OF PARKS AND WATERCRAFT, WATERWAYS SAFETY FUND PROGRAM ON BEHALF OF THE CITY OF STRUTHERS FOR ENHANCING THE PUBLIC HAND-POWERED WATERCRAFT ACCESS TO THE MAHONING RIVER AND AGREE TO OBLIGATE THE NECESSARY FUNDS TO COMPLETE THE PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, the State of Ohio, through the Ohio Department of Natural Resources Waterways Safety Fund, administers financial assistance for public hand-powered watercraft access to the Mahoning River; and,

WHEREAS, the City of Struthers desires financial assistance under the Waterways Safety Fund Program for, paving, curbs, signs, markings and information kiosks located at the site of the public hand-powered watercraft access to the Mahoning River.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Struthers, Ohio, ³/₄'s of all members elected thereto concurring:

SECTION 1: That the City of Struthers approves filing an application for financial assistance.

SECTION 2: That the Mayor is hereby authorized and directed to execute and file an application with the Ohio Department of Natural Resources Waterways Safety Fund and to provide all information and documentation required to become eligible for possible funding assistance.

SECTION 3: That the City of Struthers does agree to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms of the Waterways Safety Fund Program.

SECTION 4: That this Resolution is hereby declared to be an emergency measure necessary for the preservation of public peace and the health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that the grant application must be filed by March 1, 2022 and, as such, this resolution shall take effect upon its passage and approval by the Mayor.
