AN ORDINANCE AUTHORIZING THE SAFETY SERVICE DIRECTOR TO INSTALL "NO PARKING" SIGNS ON BOTH SIDES OF WEST HARVEY STREET BETWEEN THE 8TH STREET INTERSECTION AND THE 10TH STREET INTERSECTION. INVOLVING THE WESTBOUND LANE, NORTH SIDE OF THE STREET, AND THE EASTBOUND LANE, SOUTH SIDE OF THE STREET, PURSUANT TO THE TRAFFIC STUDY RECOMMENDATIONS AND DECLARING AN EMERGENCY.

NOW, THEREFORE BE IT ORDAINED, by the Council of the City of Struthers, Ohio 3/4's of all members elected thereto concurring.

SECTION 1: Pursuant to R.C. §4511.11, the City of Struthers has authority to place and maintain traffic control devices to regulate traffic.

SECTION 2: That the Safety Service Director is hereby authorized to install "NO PARKING" signs on both sides of West Harvey Street between the 8th street intersection and the 10th street intersection, involving the westbound lane, north side of the street, and the eastbound lane, south side of the street, pursuant to the traffic study recommendations.

SECTION 3: The Safety Service Director together with the Street Department are hereby directed to erect appropriate "NO PARKING" signs on both sides of West Harvey Street between the 8th street intersection and the 10th street intersection, involving the westbound lane, north side of the street, and the eastbound lane, south side of the street, pursuant to the traffic study recommendations.

SECTION 4: This ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that said traffic signs are necessary to prevent a traffic problem on such street, and, as such, this ordinance shall take effect upon its passage and approval by the Mayor.
