A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF STRUTHERS TO SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO DEPARTMENT OF NATURAL RESOURCES NATUREWORKS GRANT PROGRAM AND DECLARING AN EMERGENCY.

Project Title: Nebo Park Wheelchair Accessible Path and Parking Area

Project Cost: The total project cost is \$162,461

WHEREAS, the State of Ohio through the Ohio Department of Natural Resources, administers financial assistance through the State of Ohio NatureWorks grant program and

WHEREAS, the City of Struthers desires financial assistance in the amount of \$54,319 for the construction of a wheelchair accessible path and parking area in the City's Nebo Park, under the NatureWorks Grant Program,

WHEREAS, The City of Struthers, agrees to a commitment of \$108,142 of cash from The City of Struthers.

NOW, THEREFORE, BE IT RESOLVED, by the council of the City of Struthers: by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring:

SECTION 1: The Council of the City of Struthers hereby authorizes an application to The Ohio Department of Natural Resources NatureWorks Grant Program in the amount of \$54,319.

SECTION 2: The City of Struthers will obtain the \$108,142 of cash to fund the project through additional grants. Should the City of Struthers not obtain \$108,142 of cash to fund the project by August 15, 2025, The City of Struthers will withdraw the project from the Ohio Department of Natural Resources NatureWorks grant program.

SECTION 3: The Mayor of Struthers, is authorized to enter into any agreements as may be necessary and appropriate for obtaining funding through The Ohio Department of Natural Resources NatureWorks Grant Program.


SECTION 4: That it is FOUND and DETERMINED that all formal actions of this Council relating to the passage of this resolution or adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees which resulted in such formal actions were made in compliance with all legal requirements, including those of section 121.22 of the Ohio Revised Code.


SECTION 5: This resolution is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that the deadline must be filled by 8/15/2024; and, as such, this resolution shall take effect immediately upon its passage and approval by the Mayor.
