A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF STRUTHERS TO SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO DEPARTMENT OF NATURAL RESOURCES, DIVISION OF PARKS AND WATERCRAFT, NAVIGATIONAL AIDS GRANT REQUEST AND DECLARING AN EMERGENCY.

Project Title: City of Struthers Mahoning River Navigational Aids

Project Cost: The total project cost is \$7,104.

WHEREAS, The City of Struthers, is requesting a \$7,104 from the Ohio Department of Natural Resources for the purchase of navigational aids.

WHEREAS, The City of Struthers, agrees to pay for costs associated with anchors, fastenings, or maintenance items related to the navigational aids.

NOW, THEREFORE, BE IT RESOLVED, by the council of the City of Struthers: by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring:

SECTION 1: The Council of the City of Struthers hereby authorizes an application to the Ohio Department of Natural Resources, Division of Parks and Watercraft, Navigational Aids Grant Request.

SECTION 2: The Mayor of Struthers, is authorized to enter into any agreements as may be necessary and appropriate for obtaining this Ohio Department of Natural Resources, Division of Parks and Watercraft, Navigational Aids Grant.

SECTION 3: That it is FOUND and DETERMINED that all formal actions of this Council relating to the passage of this Resolution or adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees which resulted in such formal actions were made in compliance with all legal requirements, including those of section 121.22 of the Ohio Revised Code.

SECTION 4: That this resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, thereof, for the reason that it is immediately necessary to contract consulting services for advice in a rapidly changing technical area, and provided it receives the necessary affirmative votes as required by the passage and be in force at the earliest period allowed by law.
