**A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF STRUTHERS TO SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO ENVIRONMENTAL PROTECTION AGENCY WATER POLLUTION CONTROL LOAN FUND (WPCLF) AND DECLARING AN EMERGENCY.**

Project Title: City of Struthers Storm Water Improvement Planning

Project Cost: The total project cost is estimated at \$128,215.

**WHEREAS**, The City of Struthers, is requesting a \$128,215 loan from the Ohio Environmental Protection Agency Water Pollution Control Loan Fund.

**WHEREAS**, The City of Struthers, agrees to pay the balance of the loan at an interest rate of 0% by the end of the 5 year term of the loan.



**NOW, THEREFORE, BE IT RESOLVED**, by the council of the City of Struthers: by the Council of the City of Struthers, Ohio,  $\frac{3}{4}$ 's of all members elected thereto concurring:

**SECTION 1:** The Council of the City of Struthers hereby authorizes an application to the Ohio Environmental Protection Agency Water Pollution Control Loan Fund for a 0% interest loan with a 5 year term in the amount of \$128,500.


**SECTION 2:** The Mayor of Struthers, is authorized to enter into any agreements as may be necessary and appropriate for obtaining this Ohio Environmental Protection Agency Water Pollution Control Loan Fund loan.

**SECTION 3:** That it is FOUND and DETERMINED that all formal actions of this Council relating to the passage of this Resolution or adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees which resulted in such formal actions were made in compliance with all legal requirements, including those of section 121.22 of the Ohio Revised Code.

**SECTION 4:** That this resolution is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, thereof, for the reason that, and provided it receives the necessary affirmative votes as required by the passage and be in force at the earliest period allowed by law.
