A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF STRUTHERS TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND / OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED AND DECLARING AND EMERGENCY.

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and.

WHEREAS, the City of Struthers is planning to make capital improvements to Bob Cene Way Street Resurfacing Project, and.

WHEREAS, the infrastructure improvement herein above described is a priority need for the community and is a qualified project under the OPWC programs,

NOW, THEREFORE, BE IT RESOLVED, by the council of the City of Struthers: by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring:

SECTION 1: That the Mayor is hereby authorized and directed to make application, enter into an agreement, and execute appropriate documents and contracts with the Ohio Public Works Commission (OPWC) for the Year 2025 Resurfacing Project.

SECTION 2: That the Auditor is hereby designated as Chief Fiscal Officer relative to all grant documents pertaining to the Year 2025 Resurfacing Project and appropriate for obtaining this financial assistance.

SECTION 3: That MS Consultants, Inc. is hereby designated as Project Manager for the Year 2025 Resurfacing Project.

SECTION 4: That it is FOUND and DETERMINED that all formal actions of this Council relating to the passage of this Resolution or adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees which resulted in such formal actions were made in compliance with all legal requirements, including those of section 121.22 of the Ohio Revised Code.

SECTION 5: This Resolution is hereby declared to be an emergency measure necessary for the preservation of public peace, health, and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact; and, as such, this Resolution shall take effect immediately upon its passage and approval by the Mayor.


