A RESOLUTION AUTHORIZING THE AUDITOR TO REQUEST AND RECEIVE THE ADVANCE DISTRIBUTION OF REAL PROPERTY TAX COLLECTIONS FROM THE MAHONING COUNTY AUDITOR FOR THE CALENDAR YEAR 2025 AND DECLARING AN EMERGENCY.

WHEREAS, the Mahoning County Auditor will begin Real Property Tax Collections for tax year 2024 pay year 2025; and,

WHEREAS, the Mahoning County Auditor has advised the City of Struthers that it may request the advance payment of said collections by Resolution per Ohio Revised Code, Section 321.34.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring:



SECTION 1: That the City of Struthers hereby requests the advance payment of Real Property Tax Collections due to the City of Struthers.


SECTION 2: Real Property Tax Collection Advances are set for Pay Calendar Year 2025 and are detailed in "Exhibit A" and attached hereto and made a part hereof: and


SECTION 3: That the Mayor of the City of Struthers is hereby directed to forward a copy of this resolution to the Office of the Mahoning County Auditor to secure the advance payments of 2024 Real Property Tax Collections pay year 2025.

SECTION 4: That it is FOUND and DETERMINED that all formal actions of this Council relating to the passage of this Resolution or adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees which resulted in such formal actions were made in compliance with all legal requirements, including those of section 121.22 of the Ohio Revised Code.

SECTION 5: This Resolution is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that Resolution must be forwarded as soon as possible, and, as such, this Resolution shall take effect upon its passage and approval by the Mayor.

- Send written request by resolution for the advance from the taxing district by e-mail at manuel.santiago@mahoningcountyoh.gov, no later than the Monday before the advance is scheduled.
- 2nd Half Advances only** – Please note that, if you have already submitted your 2025 resolution stating that you are authorized to receive advances when funds are available throughout the calendar year, you do not need to pass a new resolution. All I will need is an e-mail requesting the funds on the dates specified.
- You may e-mail more than one request at once to cover all advance dates. Mention each date in your request.
