**AN ORDINANCE CREATING § 135.06 OF THE CODIFIED
ORDINANCES OF THE CITY OF STRUTHERS PROVIDING
THAT ALL WRITTEN CIVIL SERVICE EXAMINATIONS FOR
POLICE OFFICERS ARE TO BE ADMINISTERED THROUGH
NATIONAL TESTING NETWORK, AND DECLARING AN
EMERGENCY.**

WHEREAS, to become a police officer in the City, potential candidates must, in addition to other things, pass a written examination that tests a candidate's aptitude and knowledge pertaining to the position of police officer.

WHEREAS, the Chief of the Struthers Police Department has requested that all such written examinations be given and administered by National Testing Network.

WHEREAS, the City's Civil Service Commission has requested that this Council authorize the use of National Testing Network for all written civil service examinations for the position of police officer.

WHEREAS, Council finds that the use of National Testing Network for all written civil service examinations for the position of police officer is in the best interest of the police department and the City.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring:

SECTION 1: § 135.06 of the Codified Ordinances of the City of Struthers is hereby created to read as follows:

135.06 WRITTEN CIVIL SERVICE EXAMINATIONS

All written civil service examinations for the position of police officer in the City are to be given and administered by National Testing Work.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were passed in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including § 121.22 of the Ohio Revised Code.

SECTION 3: This Ordinance is an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the City and for the efficient daily operation of the City's departments, specially including, but not necessarily limited to, the Police Department. Accordingly, this Ordinance shall be in full force and effect from and immediately upon its passage and approval by the Mayor.
