A RESOLUTION AUTHORIZING THE MAYOR OR HER DESIGNEE TO FILE AN APPLICATION(S) WITH THE OHIO DEPARTMENT OF TRANSPORTATION FOR GRANTS THROUGH THE FEDERAL TRANSIT ADMINISTRATION AND THE STATE OF OHIO TO PURCHASE A NEW SENIOR VAN AND TO EXECUTE A CONTRACT(S) WITH THE OHIO DEPARTMENT OF TRANSPORTATION UPON PROJECT APPROVAL, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Struthers seeks to purchase a new senior van;

WHEREAS, the Director of the Ohio Department of Transportation (“ODOT”) is authorized to make grants for the Federal Transit Administration (the “FTA”) funds and the State of Ohio;

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including the provision by it of the local share of the project costs in the program if applicable; and

WHEREAS, in accordance with the provisions of Title VI of the Civil Rights Act of 1964, it is required by the U.S. Department of Transportation that, in connection with the filing of an application for assistance, the applicant gives an assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the requirements of the U.S. Department of Transportation thereunder.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring as follows:

SECTION 1: That the Mayor or her designee is authorized on behalf of the City.

- a. to execute and file
 - i. Proposals to aid in the financing of capital, operating, and planning assistance projects;
 - ii. Grant agreements with the ODOT for aid in the financing of capital, operating, and planning assistance projects;
 - iii. An assurance or any other document required by the U.S. Department of Transportation effectuating the purposes of Title VI of the Civil Rights Act of 1964; and
 - iv. Set forth affirmative disadvantage business policies in connection to any procurement made as part of the project.


SECTION 2: That the Mayor or her designee is authorized to furnish such additional information as the Ohio Department of Transportation may require in connection with the proposal for the program of projects submitted to the Federal Transit Administration and the State of Ohio.


SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were passed in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including § 121.22 of the Ohio Revised Code.

SECTION 4: A delay in the effective date of this resolution will result in detriment to the economic health, safety and welfare of the Struthers community at large. Accordingly, this resolution is hereby declared to be an emergency measure necessary for the immediate preservation of public peace, health, safety and welfare of the City and shall therefore be in full force and effect from and immediately upon its passage and approval by the Mayor.
