**AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF
STRUTHERS TO SUBMIT AN APPLICATION TO PARTICIPATE IN
THE EASTGATE ARC FY2026 AREA DEVELOPMENT GRANT
PROGRAM AND TO EXECUTE DOCUMENTS AS REQUIRED AND
DECLARING AN EMERGENCY.**

Project Title: Struthers Water Pollution Control Facility Upgrades

Project Cost: The total project cost is \$216,918.

WHEREAS, The City of Struthers, is requesting \$108,400 in ARC funding; and,
WHEREAS, The City of Struthers, agrees to a commitment of \$108,518 of cash
from The City of Struthers Wastewater Fund.

NOW, THEREFORE, BE IT ORDAINED, by the council of the City of
Struthers: by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected
thereto concurring:

SECTION 1: The Council of the City of Struthers hereby authorizes an
application to the Eastgate ARC FY26 Area Development program for funds in the
amount of \$216,918.

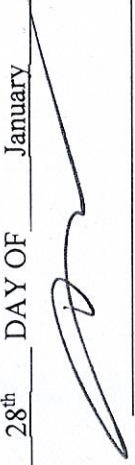
SECTION 2: The Mayor of Struthers, is authorized to enter into any agreements
as may be necessary and appropriate for obtaining this Appalachian Regional
Commission financial assistance.

SECTION 3: Council hereby finds and determines that all formal actions relative
to the passage of this Ordinance were taken in an open meeting of this Council, that all
deliberations of this Council and of its committees, if any, which resulted in formal action
were taken in meetings open to the public, in full compliance with the applicable legal
requirements, including § 121.22 of the Ohio Revised Code.

SECTION 4: This ordinance is hereby declared to be an emergency measure
necessary for the preservation of public peace, health and safety of the inhabitants of the
City of Struthers, Ohio. Said emergency exists by reason of the fact that; and, as such,
this ordinance shall take effect immediately upon its passage and approval by the Mayor.
