**NO. 26-017**

**A RESOLUTION CONFIRMING THAT THE MAYOR AND AUDITOR OF THE CITY OF STRUTHERS SHALL SERVE ON THE MAHONING COUNTY TAX INCENTIVE REVIEW COUNCIL (TIRC) FOR 2026 AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City of Struthers is part of an approved Enterprise Zone consisting of the Cities of Campbell and Struthers, the Village of Lowellville and Coitsville Township; and,

**WHEREAS**, the State of Ohio's Enterprise Zone Program required the formation of a Tax Incentive Review Council (TIRC) to monitor the activities of the Enterprise Zones; and,

**WHEREAS**, the City of Struthers is to appoint two members to serve on the Mahoning County Tax Incentive Review Council for 2026.

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of the City of Struthers, Ohio,  $\frac{3}{4}$ 's of all members elected thereto concurring:


**SECTION 1:** Struthers City Council confirms that the Mayor, Catherine Cercone Miller and the City Auditor, Christina Bohl, shall serve on the Mahoning County Tax Incentive Review Council (TIRC) for the year 2026.

**SECTION 2:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were passed in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including § 121.22 of the Ohio Revised Code.

**SECTION 3:** This Resolution is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that confirmation of TIRC representatives must be filed with the State of Ohio as soon as possible, and, as such, this Resolution shall take effect upon its passage and approval by the Mayor.
