**AN ORDINANCE APPROPRIATING THE SUM NOT TO EXCEED \$1,000.00
FROM THE 2026 GENERAL FUND BUDGET APPROPRIATION 9000
MISCELLANEOUS CATEGORY CONTINGENT # 100 9000 53024 TO
WILLOW CREMATION SERVICES FOR AN INDIGENT STRUTHERS
RESIDENT AND DECLARING AN EMERGENCY.**

WHEREAS, a request has been directed to the Struthers City Council to appropriate the sum of \$1,000.00 to Willow Cremation Services, 1350 North Canfield Niles Rd., Mineral Ridge, Ohio, 44440 for the purpose of disposing an indigent Struthers resident.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring:

SECTION 1: Council deems it appropriate to grant the Higgins-Reardon Funeral Home and Cremation Services the sum of \$1,000.00; furthermore, the Auditor is directed to forward said sum immediately to Willow Cremation Services; appropriation to be charged against the 2026 General Fund Budget Appropriation 9000 Miscellaneous Category Contingent # 100 9000 53024.

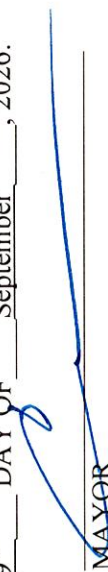
SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were passed in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including § 121.22 of the Ohio Revised Code.

SECTION 3: This Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that said person is indigent and said bill needs paid for disposal of body, and, as such, this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor.
