CASTLO

The CASTLO Community Improvement Corporation received a \$91,000 grant to rehabilitate a railroad bridge in the industrial park.

Street Resurfacing 2021

We will soon be awarding the bid for the 2021 street resurfacing project. We expect this to be completed by end of October.

Water Pollution Control Department

Mahoning County Fire Chiefs Association received the largest federal grant it has ever received of \$1,676,436,36 to purchase radios and make us compliant with the Statewide Communications Interoperability Plan. This will be shared between Austintown, Berlin, Boardman, Campbell, Canfield, Coitsville, Craig Beach, Ellsworth, Green, Jackson, Lowellville, New Middletown, Springfield, Poland and Struthers with the Western Reserve Fire District serving as the grant administrator.
