**AN ORDINANCE TO APPROVE CURRENT REPLACEMENT PAGES TO
THE STRUTHERS CODIFIED ORDINANCES AND DECLARING AN
EMERGENCY.**

WHEREAS, the Ohio Constitution requires that Ohio municipal ordinances comply with State law if they are an exercise of the Municipality's police powers;

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State law; and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances; and

WHEREAS, the City has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is before Council;

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Struthers, Ohio, 3/4's of all members elected thereto concurring:

SECTION 1: That the ordinances of the City of Struthers, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2020 Replacement Pages to the Codified Ordinances, are hereby approved and adopted.

SECTION 2: That the following sections and chapters are hereby added, amended or repealed as respectively indicated in order to comply with current State law.

Traffic Code

- 331.43 Wearing Earplugs or Earphones Prohibited. (Amended)**
- 335.09 Display of License Plates or Validation Stickers; Temporary License Placard. (Amended)**
- 335.091 Operating Without Dealer or Manufacturer License Plates. (Added)**

General Offenses Code

- 505.04 Abandoning Animals. (Amended)**
- 513.01 Drug Abuse Control Definitions. (Amended)**
- 537.17 Reserved. (Previously "Criminal Child Enticement")**

SECTION 3: That the complete text of the sections listed above are set forth in full in the current replacement pages to the Codified Ordinances which are hereby attached to this ordinance as Exhibit A. The listing above of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

SECTION 4: That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Municipality and its inhabitants for the reason that there exists an imperative necessity for the earliest publication and distribution of current Replacement Pages to the officials and residents of the Municipality, so as to facilitate administration, daily operation and avoid practical and legal entanglements, including conflict with general State law, and providing it receives the affirmative vote of 3/4's of the members elected to the legislative authority, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
